REWARD FOR DOUBLE MURDER

By Joseph Wiszowaty SAUK VILLAGE | Marcus Mireles and his friend Abel Galindo were found dead in a home at 22642 Brookwood in Sauk Village the evening of Tuesday, December 6, 2011 and nearly two months later still nothing from temporary Sauk Village Police Chief Robert Fox.

During a recent conversation with Fox "it's still under investigation".

"We have not heard anything at all. No details nothing on the investigation. The only thing we hear is what we see in the newspapers or what is posted online" Roxanne Mireles said to the Sauk Villager.

"In the beginning we have had contact with Detectives Grossman and Detective Sergeant Holevis but now we're hearing nothing.

Now the families of one of the deceased men are putting up a reward of \$10,000

in hopes of sparking some interest and more important leading to the arrest and convictions of the person or persons responsible for the murders.

The SAUK VILLAGER has heard an unconfirmed rumor as early as December 11th that had circulated that a suspect had made a confession to the murders and that there was a possible accomplice but the Cook County States Attor-

ney refused to press charges allegedly claiming "lack of evidence". The Cook County States Attorney's office did not respond to messages regarding this matter. Sauk Village Police Chief Robert Fox said he would not comment other than to say the investigation is ongoing.

"I've spoken to the families" Fox said. But Roxanne Mireles said that other than Fox offering his condolences to the family shortly after the discovery of the men, Fox has not returned her calls or her family's calls as late as yesterday. Mireles wants answers and wants to know what the police are doing.

"I'm wondering if all the drama with the police chief is why we're not hearing anything" Mireles wondered referring to the controversy surrounding Fox recently.

Tax Bills Due March 1st



Pappas
encourages
residents to
pay online

CHICAGO – Cook County Treasurer Maria Pappas said today that the 2011 First Installment property tax bills are due March 1, 2012. Pappas encourages paying online at cookcountytreasurer.com to avoid traveling during the winter season. Payments received after

the March 1, 2012, due date will be charged a 1.5 percent penalty per month. Property owners can pay:

Online at cookcountytreasurer.com, from a checking or savings account.

At more than 400 Chase Bank locations in Chicagoland · From an account at some 200 participating community banks

By mail with a postmark no later than March 1, 2012 · At the Cook County Treasurer's Office located in downtown Chicago "Paying online allows you to sit at a computer and avoid traveling through winter weather," Pappas said. "Your fingers do the walking, but

you don't." Partial payments are accepted. All forms of payment require taxpayers to reference their 14-digit Property Index Number (PIN) located at the top of each tax bill.

Many property owners have their taxes paid from an escrow account managed by mortgage lenders. It is the owner's responsibility to ensure that the lender pays on the correct PIN before the due date. Taxpayers can call 312.443.5100 for information in English, Polish and Spanish.
