### WATER UPDATE

The village is under a legal order with the Illinois Attorney General to provide safe drinking water for its residents! The Village is in compliance with this order and is conducting ongoing tests to ensure there are no harmful levels of contaminants in the village's water supply. Keep in mind, that while the water drawn from the wells still shows the presence of Vi-

nyl Chloride, a known carcinogen, none is reaching your home or local businesses because of the Illinois Environmental Protection Agency 2012 mandate to install "Emergency" air strippers.

Please know that the residents voted to bring Lake Michigan water to Sauk Village in March, 2012. With this referendum, the residents agreed to the significant water rate increases needed to pay

for the infrastructure improvements required by the Illinois Department of Natural Resources (IDNR) in order to qualify for access to Lake Michigan Water. Since 2012, Sauk Village water rates have increased from \$3.50 per 1000 gallons to its current level of \$7.50 per 1,000 gallons; projected to exceed well over \$10.00 per 1,000 gallons in order to make the required improvements to our 58 year old water system. However, none of the water rate increases you have been paying have gone towards any provisions for Lake Michigan water. As your Village Trustee, I have been discussing Sauk Village's need for assistance with our Federal, State and County officials. Sauk Village has a written plan on file to transition to Lake Michigan water; however, none of the recommendations of that plan have been enacted other than to secure funding for the "Temporary" air strippers to remove the vinyl chloride. We have also used that funding to update our current Iron Removal System used to remove the heavy iron sediment out of the water.

With water rates projected at this level, Sauk Village will need all the outside assistance it can get to make the mandate of the people a reality.

My goal, as your Trustee, is to continue face time with our Federal, State and other local officials to secure a viable long term solution. Let's work together toward that goal!

## Long awaited Jeffrey Ave repairs begin this week



Repairs on Jeffrey Avenue are beginning now and are scheduled to be completed by the end of September.

The project is funded using Motor Fuel Tax not property tax dollars!

As many of you know Jeffrey Avenue from Sauk Trail to 217th Place has been like a mine field and it has never been quite right since it was installed in the 1970s.
