Roger Theisen, then Mayor of Sauk Village presented Johnson with the "Key to the City". Theisen was pleased to be a part of the ceremony to honor Mr. Johnson, who was then age 22.

Johnson won the 1968 Illinois state high school championship while competing at Bloom High School for pole vaulting. He was a Gold Medalist in the 1971 Pan American Games and a Bronze Medalist at the 1972 Olympic Games in Munich Germany for pole vaulting.

Not too many people in Sauk Village today remember these little known facts, but it's my intention to remind them because Sauk Village is rich in history!

Village Trustee Derrick Burgess announced has been working with his Economic Development Committee to create Sauk Village's first Community Development Plan.

The Plan will include, among other things, building standards and guidelines for new and existing business,

something that Sauk Village has never had before according to Burgess.

"We want to move the village forward and not get wrapped up in the politics of the moment" Burgess said.

"The Village has got to have a plan to move forward. We've never had a plan in place as a guide. Our committee is working to put the plan together and it's not an easy task. We have many problems we're facing locally and nationally but Sauk Village is strategically located and we have the incentives, the room and infrastructure in place to make things happen" Burgess said.

Burgess expects to have the Community Development Plan complete in 2012.

Village Board to ensure *Temporary*Appointments are *Temporary*

SAUK VILLAGE | The Village Board of Trustees voted 5 to 1 to limit the mayor's temporary appointment powers to ensure that they are temporary and not permanent.

The Ordinance reads "All appointive officers of the village shall be appointed by the mayor, with the advice and consent of the corporate authorities. A mayoral nominee for appointment failing to receive a majority vote of all elected trustees may serve as a temporary appointment for a period of 30 days. At the expiration of this 30-day period, the Mayor may resubmit the same nominee for appointment. If the nominee again fails to receive a majority vote of all elected trustees, the nominee will remain in his or her position for a second 30-day period. At the expiration of the second 30-day period, the Mayor must submit a new name for consideration by the corporate authorities. No temporary appointment of any one person shall be made more than twice in any one fiscal year"

The ordinance was vetoed by Mayor Lewis Towers, however, the veto is not likely to stand since the Village Board will likely over-ride the veto which requires just 4 votes to over-ride the veto.

The action taken by the board will impact the Police Chief appointment of Robert Fox since the ordinance was passed and in force at the time of the appointment.

The Village Attorney advised the Village Board that the action taken was appropriate that at no time were any other municipalities ever challenged on the matter with respect to the ordinance.

Towers bends to Will of the People—but only a little bit

Wiszowaty - A few weeks ago, Sauk Village Mayor Lewis Towers threatened to sue the Village Board and the taxpayers of Sauk Village over what he called "the process" of hiring a Village Manager

On Tuesday, November 8th, Towers welcomed Henrietta Turner, the new Village Manager and appeared to capitulate on his "Imma sue you" stance.

I'm glad that Towers accepted the 5 to 1 majority and in this case has worked with the Village Board and not against them. Now this is definitely the exception and certainly not the rule. Towers has not exactly been the model of representative government, but in this one case I would be remiss if I didn't acknowledge the fact that he did give in to the will of the majority.

For the first time following the April, 2011 election, where his candidates lost by nearly a 3 to 1 margin, he's given in to the will of the People of Sauk Village. Yes this was a first by this Mayor.


The Village can neither afford a lawsuit and the people of Sauk Village definitely support the majority of the Village Board. Who is Lewis Towers?

This is a first in a series of articles which will feature elected officials from Sauk Village We begin the series with the "top dog" Mayor Lewis Towers.

Not much was known about Lewis Towers when he decided to run for Mayor in the Summer of 2008.

On his campaign literature Towers states he "knew people in high places", that he had "excellent leadership skill (sic)" and he was going to "bring change to Sauk Village with an open and transparent government".

Lewis Towers, age 61 was born in Greenwood, Mississippi. His early edu- B cation was in the Leflore County school system, Graduating from Amanda Elzy Former Mayor Roger Peckham did not High School in 1969. He is a graduate of Mississippi Valley State University. After graduation he moved to Chicago, IL.

Towers said shortly after taking office "rest assured we will have an open and transparent government". Towers lived in Chicago for over twenty four years.

Towers is employed as a manager with the Cook County Assessor's Department (more than nineteen years) in the Markham,

Many rumors have circulated as to when Towers actually did move to Sauk Village. According to the Village's website Towers moved to Sauk Village, IL in 1998 and became an "active resident in the community." However, according to the Illinois Election Board, Lewis and Maxine Towers made a contribution the 19t Ward Democratic organization on June 16, 2008. Illinois law requires at least 12 months residency in order to offices. for local

Towers only previous involvement with the Village prior to being elected to Mayor was that he served on the Police and Fire Commissioner Board, sat on and attended the Parks and Recreation Committee and Sauk Village Zoning

seek re-election in 2009 and did not endorse any candidate.

Towers publicly supported now former Trustee Francine Anderson and her two Towers and his wife Maxine have been running mates Lynda Washington and

married over thirty seven years they Darrick "Lil D" Thompson who were

had two homestead exemptions on his property in Chicago and in Sauk Village. Also, Towers did not have a front license plate as required by Illinois law on his 2003 Jaguar and recently put the license plate back on this vehicle, sparking speculation that he will run for reelection.

Shortly after Towers took office in May, 2009, he appointed his campaign manager, Brunetta Hill-Corlry as his Chief of Staff, a position that he abolished the Village Manager's position to create.

Hill-Corley and Towers's Police Chief Frank Martin, an elected Alderman from Country Club Hills, were fired "with cause" in May, 2010 and have been named as defendants in multiple lawsuits alleging, among other things, discrimination by white employees.

The Village settled a Federal lawsuit in September of this year with three employees for an undisclosed amount. The employees in the case claimed both Hill-Corley and Martin treated and held white employees to different standards. An estimate on the settlement number with the employees from exports put the settlement from \$350,000 to

Towers is said to have told several people that he will be running for reelection in 2013, however nobody has announced their intention to run for Mayor in April, 2013.
