

POLICE CHIEF POLITICAL PAWN?

By Joseph Wiszowaty **SAUK VILLAGE** | When Lewis Towers appointed temporary Police Chief Robert Fox last week he did so without so much as a vote by the Village Board of Trustees.

The controversy over temporary Police Chief is not over, Fox will only be able to serve until January 21, 2012, that's because under the recently passed ordinance of the Village Board, the Mayor can only appoint "temporary appointees" to no more than two 30 days appointments.

Fox, will not likely garner enough votes to continue after January 21st and his re-appointment will not likely garner a second so his appointment will never be voted on.

Why has it come to this? In 2009, when Towers was first elected, then Police Chief Tom Lacheta remained

in the position, a hold over from the previous administration. Later that year, Lacheta retired, at that time Towers formed a "committee" to search for a police chief. Towers put Frank Martin's name into the mix

and he was appointed in January, 2010 by a 4 to 2 vote with Trustee Derrick Burgess and Rosie Williams voting no to that appointment.

Martin's command as police chief was the shortest in Sauk Village history, only 5 months. Martin was one of the primary sources of lawsuits filed by numerous police officers alleging, among other things, discriminatory actions. Martin was the first African-American police chief also serves as Alderman of Country Club Hills, Illinois. Martin was fired in May, 2010 "with cause" by the Village Board.

Holevis was pulled into the position as "interim Police Chief" and served there from June, 2010 until last week. Towers informed Holevis through the new Village Manager (Cont'd pg 7 see **CHIEF**)

Home Values Up

Home prices have increased in Sauk Village slightly in the third quarter of 2011, the second consecutive quarterly increase this year. After falling in 2009 and again in a "double dip" in the first quarter of 2011, prices have rebounded. This is likely attributed to the foreclosure process having played its way out.

Budget cuts in 2010 forced the Village Board to layoff the entire code enforcement department. With the lack of a code enforcement properties have deteriorated holding home values down and the Village has become an investment haven for investors.

1957-1965






Mark J. Collins Village Trustee 1987-1989 Mayor– 1989-1997

Sauk Village has had only 6 mayors in it's history, however the history of the village actually dates back to 1839 when the settlement of New Strassburg was founded.

Thomas Nichols became Sauk Village's first Mayor in 1957. In 1959, just two years after incorporation, the end of Sauk Village seemed inevitable and talks were under way to dissolve Sauk Village as a community. Nichols and the Village Board fought back and the commu-



Roger Theisen Trustee 1964-1965 Mayor- 1965-1977





nity remained and would soon become the fastest growing community in the State of Illinois. In February, 1959 Sauk Village would lead the area in home building permits.

In 1963, a record 5 of the 6 Village Trustee seats were up for election, 2 of which were unexpired terms. Matthew Murphy was the only Trustee who was not up for election. 5 new Village Trustees came to the Village Board in 1963, and a new Mayor would come to Sauk Village in 1965.

Roger Theisen who joined the Village Board one year earlier was elected Mayor. Under Theisen's administration, the Village experienced some of the fastest growth that has ever occurred in terms of residential growth in the Village's history.

Subdivisions such as St. James Estates, Bell Aire, Surreybrook and Indiana Hills all started to take shape.

MAYOR- (Cont'd from page 3) In 1973, Theisen was re-elected as the first full-time mayor and Sauk Village was experiencing unprecedented growth and was among the fastest growing communities in Cook County.

Theisen's final term in office saw significant residential growth and a battle with the Cook County Forest Preserve which was gobbling up land Sauk Village wanted for residential growth.

In 1977, the Theisen era came to an end. The tears had started to flow on election night before the final precinct reported in. Everyone knew it was the end of an era. Theisen's election night headquarters at the Personality Lounge (the now closed Tui's) was somber when the final precinct reported, Theisen had lost.

"I've been praying to God to do what he felt best. Apparently He has other things in mind for us" Ginger Theisen wife of Mayor Roger Theisen said.

"I'll always be proud of what I've done for Sauk Village. The election's over, we're all friends, let's look to the future again" Theisen said on election night.

Edward Paesel, defeated Theisen by just 96 votes. Theisen, moved shortly after the election and retired in Florida.

Paesel was 27 years old when he took office as the only other full-time Mayor. Paesel was a school teacher at St. Marks School in Sauk Village and served as principal.

There wasn't a long transition, only 1 week to get ready to take over and Paesel worked with Theisen after the election so he could hit the ground running. An instrumental part of the continuity Paesel credited was Village Administrator Ted Theodore.

Paesel brought a level of professionalism to the office that continued until he left office in 1989. Paesel worked to help expand Roadway and lured another trucking terminal to Sauk Village in 1988. Paesel's most aggressive economic development was to bring a GM auto plant to property located in what is now the LogistiCenter west of Illinois 394. The auto plant would have brought hundreds of jobs to the area, however, the Saturn plant was built elsewhere.

In 1988, Paesel decided not to seek reelection and his thoughts turned to when he took office. "There was nobody here that could take over" Paesel said. Paesel's answer was to hire a professional Village Manager and make the Mayor's position part-time once again, a controversial issue of the day. Paesel Peckham's term in office the Village experienced more industrial growth and a national developer DP Partners was found to develop and market the LogistiCenter and the park began to take of prior to the national economic downturn. Peckham campaigned for mayor on a platform of wanting to "keep the residents here in the Village" a promise he was not able to keep.

Under Peckham's administration the Village saw the most significant housing construction since the 1960's 281 new housing permits were added under his

cast the tie-breaking vote on the matter and after a national search Richard Dieterich was hired.

On May 9, 1989, Paesel passed the gavel to his handpicked successor Village Trustee Mark Collins who during his term had one of the biggest single annexations since Roger Theisen with the annexation of the area west of Illinois 394. Collins's administration made obligations and took on many risks to the Village for the LogisiCenter without a developer ready to move forward. Collins was also facing investigation for improprieties with the Community Development Block grant program, allegations which were later resolved.

Collins was soundly defeated for a third-term by his appointed Village Trustee Roger Peckham. During term in office.

Facing demographic changes in Sauk Village and some personal health issues, Peckham announced he would not seek that elusive 4th term that Roger Theisen failed to achieve in 1977. Peckham bowed out gracefully after the construction of a new multi-million dollar Municipal Center which has not been paid for from tax dollars but from impact fees generated from the Logisticenter.

This made way for Lewis Towers' victory in 2009 since Peckham didn't seek that elusive 4th term and Peckham endorsed no candidate for mayor. Towers' history hasn't been written yet, but it will be the good bad and ugly. Will history be kind to Lewis Towers? We'll see, stay tuned!

Temporary Appointments

SAUK VILLAGE | The Village Board of Trustees voted 5 to 1 to limit the mayor's temporary appointment powers to ensure that they are temporary and not permanent.

will remain in his or her position for a second 30-day period. At the expiration of the second 30-day period, the Mayor must submit a new name for consideration by the corporate authorities. No temporary appointment of any one person shall be made more than twice in

any one fiscal year"

The ordinance was vetoed by Mayor Lewis Towers, however, the veto is not likely to stand since the Village Board will likely override the veto which requires just 4 votes to over-ride the veto.



The Ordinance reads "All appointive officers of the village shall be appointed by the mayor, with the advice and consent of the corporate authorities. A mayoral nominee for appointment failing to receive a majority vote of all elected trustees may serve as a temporary appointment for a period of 30 days. At the expiration of this 30-day period, the Mayor may resubmit the same nominee for appointment. If the nominee again fails to receive a majority vote of all elected trustees, the nominee

The action taken by the board will impact the Police Chief appointment of Robert Fox since the ordinance was passed and in force at the time of the appointment.

The Village Attorney advised the Village Board that the action taken was appropriate that at no time were any other municipalities ever challenged on the matter with respect to the ordinance.


